His multifaceted experience includes other pivotal roles at global tech giants such as Microsoft, Google, and Netflix. With his proven track record of orchestrating strategic

With its geographical scope across Europe, the company aims to make a significant contribution to ramping up e-mobility – by providing a powerful and reliable charging network.

IONITY is building and operating the largest open brand High Power Charging (HPC) network along European highways. The HPC charging capacity of up to 350 kW allows maximum charging speeds.
